### <u>Report of Voting Results</u> (Section 11.3 of National Instrument 51-102)

This report describes the matters voted upon and the outcome of the votes conducted at the Annual Meeting of Shareholders of Cara Operations Limited (the "Corporation") held on May 5, 2017.

There were present at the meeting registered shareholders and proxy holders holding or authorized to vote 15,160,717 subordinate voting shares (carrying one vote per share), being 59.22% of the issued and outstanding subordinate voting shares of the Corporation, and Cara Holdings Limited and Fairfax Financial Holdings Limited and its affiliates are authorized to vote 34,396,284 multiple voting shares (carrying 25 votes per share), being 100% of the issued and outstanding multiple voting shares of the Corporation.
